Flu vs Coronavirus ... some perspective.

All data gathered from WHO estimates and reports as of March 9, 2020.

2018-19 Flu Season in the US only

Infections - 35,500,000

Deaths - 34,200

2019-20 Flu Season in the US only through February 29, 2020

Infections - 34-49,000,000
Deaths - 20-52,000

2019-2020 Coronavirus Globally through March 9, 2020

Infections - 109,577
Deaths - 3809

2019-2020 Coronavirus in the US through March 9, 2020

Infections - 213
Deaths – 11

The China mortality rate to date is 3.8%. 3136 deaths out of 80754 infections. 2018/19 US Flu mortality rate was .09%

The mortality rate is much higher based on data available today, but we won't know precisely what it is until more testing is done.

This is very serious and we won't know the full impact for some time. The unknowns are the scary part. However, the number of infections and deaths so far are drastically less than what we typically see with the flu annually here in the US:

- 213 infections versus 35-40,000,000
- 11 deaths versus 34,200.
